Donations qualify for charitable deductions for tax benefits. In addition, a 50% tax credit per year up to \$200 joint filers (\$100 per individual) and up to \$1,000 for corporation is all to Idaho library districts.

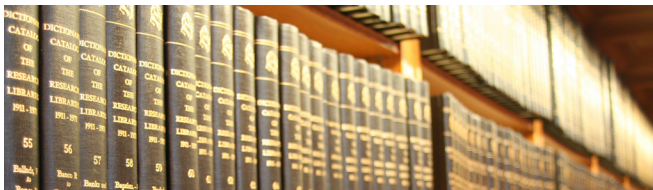

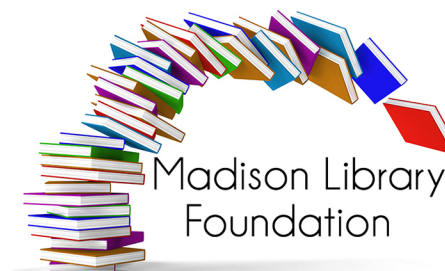
